Dr Annie Moulden, Clinical Lead Paediatric Clinical Network

Annie has 25 years of clinical experience as Paediatrician and is a self-described Quality and Safety activist. She was awarded an Order of Australia Medal (OAM) in 2011 for her contribution to Paediatrics and to Patient Safety. Annie has had previous roles as the Director of Quality at RCH and the Clinical Director, Innovation and Quality at Monash Health and is currently the Medical Lead, Quality & Safety at RCH.



Professor David Pilcher, Clinical Lead Critical Care Clinical Network, Safer Care Victoria

David Pilcher is an Intensive Care Specialist at The Alfred Hospital in Melbourne and the Clinical Lead for the Critical Care Clinical Network, Safer Care Victoria. He trained in respiratory and general medicine in the UK before moving to Australia in 2002 to undertake training in Intensive Care Medicine. He is also an Adjunct Clinical Professor with the Department of Epidemiology and Preventive Medicine at Monash University.
